HOW TO USE THE DANIELS M307 (PYLE NATIONAL TP-201393) CRIMP TOOL

GENERAL INFORMATION

- The tool has a double action ratchet. Note that the tool cannot be opened without completing the cycle.
- Designation M307 refers to the basic hand tool without positioners. The PYLE NATIONAL part number for this tool is TP-201393.

PYLE NATIONAL positioners used with this tool are as follows: TP-201388-08, TP-201388-12, TP-201388-16, and TP-201388-16G.

3. Size: 9.75" x 2.5" x 1.25" Weight: 15oz.

SETTING UP INSTRUCTIONS

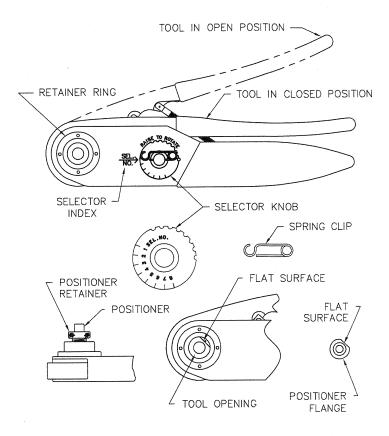
- 1. The tool must be in the open position.
- Place selected positioner through the Retainer Ring, with the flat on the flange of the positioner aligned with the flat in the tool opening. With the positioner fully seated into the tool, place Positioner Retainer over the positioner and turn clockwise to secure positioner firmly in place.
- Refer to the dataplate on the tool body.
 From the proper wire size column, determine the selector number that corresponds with the contact being used.
- 4. Remove Spring Clip from the selector knob. Raise selector knob and rotate until selector number is in line with index mark. Replace Spring Clip (optional).

CRIMPING INSTRUCTIONS

- 1. Insert contact and prepared wire through the indenter opening into the positioner.
- Squeeze handles together until ratchet releases. The handles will return to the open position. Remove the crimped contact and wire.

REMOVING POSITIONER

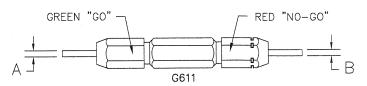
 Unscrew the Positioner Retainer by turning counterclockwise. The positioner may now be removed or replaced.

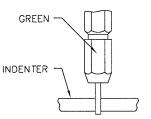
GAGING INSTRUCTIONS

"GO" GAGING

Operate tool to fully closed position. Maintain firm hand pressure on the tool handles. Insert "GO" gage end as shown. Gage must pass freely between indenter tips.

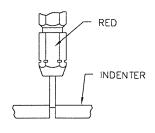
"NO-GO" GAGING

Operate tool to the fully closed position. Maintain firm hand pressure on the tool handles. Try to insert the "NO-GO" gage end as shown. The "NO-GO" gage may partially enter the indenter opening, but must not pass completely through the opening.
